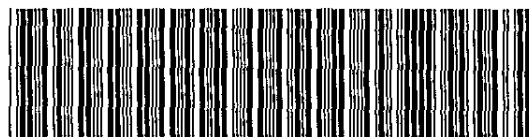



**AMENDMENT TO ARTICLES OF


1. The LLC Agreement shall be amended to name one member of SAME PROPERTIES, LLC, to FREDERICK L. BATEMAN, JR.
2. Except as expressly stated herein, all other provisions of the original Articles of Organization of SAME PROPERTIES, LLC shall remain in full force and effect.


