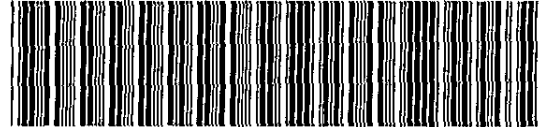

Roberto Sanson                      Manager"


