ARTICLES OF ORGANIZATION
FOR
DKDR Enterprises, LLC

The undersigned, for the purpose of forming a limited liability company under the laws of the State of Florida, hereby adopts the following Articles of Organization:

ARTICLE I
(Name)

The name of the limited liability company is DKDR Enterprises, LLC ("the Company").

ARTICLE II
(Address)

The principal office and street mailing address of the Company will be located at 317 Lauden Court, Ponte Vedra Beach, FL 32082.

ARTICLE III
(Duration and Continuation)

The Company shall have perpetual existence, commencing upon June 17, 2004, or such other date no more than five (5) days prior to the filing of these Articles of Organization with the Florida Department of State, whichever is later.

ARTICLE IV
(Purpose)

ARTICLE VI
(Additional Members)

Additional members may be admitted as provided in the Operating Agreement of the

**ARTICLE VII
(Members' Rights to Continue Business)**

The right, if given, of the remaining members of the Company to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event that terminates the continued membership of a member in the Company will be as provided in the Operating Agreement of the Company.

**ARTICLE VIII
(Members' Preemptive Rights)**

All members shall have preemptive rights with respect to any units by the company subsequent to the date on which such member purchased his or her units. The preemptive right of each individual member shall entitle such member to purchase a percentage of the units to be issued by the company such that his or her proportionate ownership interest in the company will remain the same.

**ARTICLE IX
(Management)**

The Company affairs will be conducted, carried on, and managed by one (1) or more members and is therefore a member-managed company. The manager will have the obligations and responsibilities described in the Operating Agreement of the Company. The name(s) of the initial member-manager(s) is/are: Dave Jordan, Ken Crane. The manager(s) will serve in that capacity until removed by the members or until his or her successor(s) is/are duly elected and qualified.
