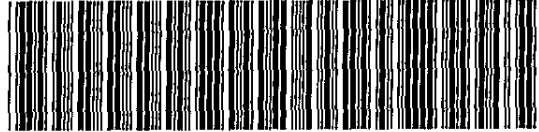


**FIRST:** The Articles of Organization were filed on JUNE 21, 2004 and assigned document number L04000046304.
