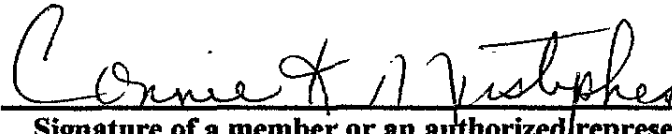

ARTICLE V – PURPOSE OF THE LIMITED LIABILITY COMPANY

Psychological and mediation services shall be provided where needed through the limited liability company's association with Dr. Alexander Gimon Ph.D & Associates. The limited liability company will also refer it's tenants for legal, medical financial planning, mortgages and other services that they may need.

The limited liability company is established to assist the elderly and disabled with maintaining their independence and self sufficiency through counseling, mediation, referral services, and providing affordable housing to meet their needs.

The limited liability company will also provide wholesale travel through it's association with New Image Marketing and other travel agencies. Through wholesale travel the limited liability company seeks to expose and educate individuals, families and youth to the world outside of their environment, including but not limited to seminars, retreats, college tours and other educational and enrichment activities.

The limited liability company will seek to obtain this goal by providing families that rent from the company, credit and financial counseling, parenting training, lessons in respecting and maintaining their residence, working toward home ownership and other services that are needed to help them become self sufficient. The company will seek to broker/partner with Human Urban Development (HUD - SECTION 8) to develop wholesome families. Training them to take care of the homes subsidized by HUD prepares them for home ownership and help families to keep it once they have obtained their own homes.

The foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the company from extending its activities to any related or otherwise permissible lawful business purposes which may become necessary, profitable or desirable for the furtherance of the company's objectives expressed above. This company is built upon faith and driven by faith. The foundation of this limited liability company is based on the belief that "to whom much is given, much is required."
