FOR

red H, LLC

ARTICLE I - Name

The name of this limited liability company shall be red H, LLC.

ARTICLE II - Duration

The limited liability company shall have a perpetual existence.

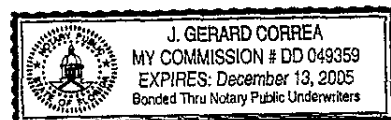
