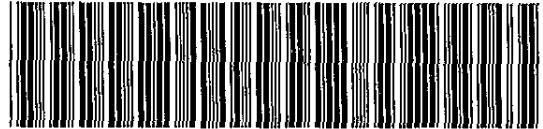

FLORIDA LIMITED LIABILITY COMPANY**

**HOLLYWOOD RENAISSANCE LIMITED LIABILITY COMPANY**

Supplemental Provisions

1. No member or members of this Limited Liability Company shall have the right to assign their interest in the Limited Liability Company, whether voluntary or involuntary, without the unanimous written agreement of all of the members (hereinafter referred to as the "Required Unanimous Vote"), unless otherwise provided in the Limited Liability Company's operating agreement.
2. If an assignment of a membership interest is not approved by the Required Unanimous Vote, the assignee (including without limitation the holder of a charging order) shall have no right to (1) become a member of this Limited Liability Company; (2) participate in the management of this Limited Liability Company; or (3) exercise any rights or powers of a member and/or manager.
3. The assignee shall merely be entitled to receive the share of profits and other distributions to which the assignor was entitled to the extent it was so assigned. Any such assignee shall be allocated and report all items of income, gain, loss, deduction, credit, or other tax allocation (a "Taxable Item") on such assignee's income tax returns and filings each year to the same extent the assignor would have been allocated such Taxable Item(s) and the assignee shall receive all federal tax forms and all relevant state Forms K-1 with respect to such allocations.
