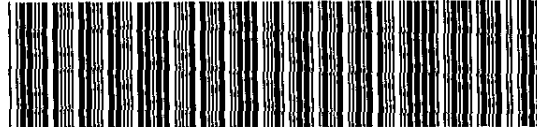

The undersigned, desiring to form a professional limited liability company under and pursuant to Florida Statute 608 entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company:

1. Name. The name of this company shall be: CYNTHIA JANUS, M.D., PL

2. Duration/Continuation. The period of this company's duration shall be perpetual, unless terminated by the unanimous written agreement of all members or as provided in the company's Operating Agreement.

3. Purpose and Powers. The purpose of the Company shall be to provide professional medical services. The Company shall be authorized to transact all lawful business for which a limited liability company may be organized under the laws of Florida.

4. The mailing address is Post Office Box 273387, Tampa, Florida 33688. The street address is 1701 Magdalene Manor Drive, Tampa, Florida 33613.

6. Initial Member(s).

7. Management of Company.

The Managerial Member shall have all authority to act on behalf of the Company.

8. Amendment of Articles of Organization.

Any amendment to these Articles of Organization shall be on such form prescribed by the Secretary of State of the State of Florida containing such terms and provisions consistent with Florida Statute 608 as shall be prescribed by the Department of State, and shall be signed and sworn to by all Members of the Company. In the event a new Member is added by such amendment, it shall be also signed by the Member to be added.

9. Regulations of Company.

The power to adopt, alter, amend or repeal the regulations of the limited liability company shall be vested in the Members unless vested in the Managerial Manager(s) of the company by any amendments of the Articles of Organization. Regulations adopted by the Members or by the Managerial Manager(s) may be repealed or altered, new regulations may be adopted by the Members, and the Members may prescribe in any regulations made by them that such regulations may not be altered, amended or repealed by the Managerial Manager without unanimous Member consent. Members may also enter into such agreements relating to the company, including an Operating Agreement, as Members deem necessary and appropriate.

10. Informal Action of Members.

Any action of the Members may be taken without a meeting if consent in writing setting forth and authorizing the action so taken shall be signed by all Members who would be entitled to vote upon such action at a meeting.

11. Transferability of Member's Interest.

An interest of a Member of this company may be transferred or assigned to such extent and in the manner provided in the Operating Agreement.
