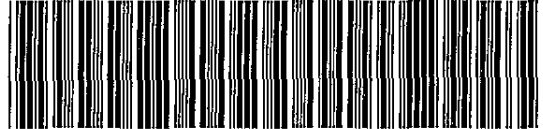

ARTICLE V
