- Name. The name of this limited liability company is CLKJAX, LLC ("Company").
- 2. Duration. The Company shall exist from the date of filing these Articles with the Department of State until the occurrence of any of the events specified in Floridal Statutes Section 608.441, unless continued by the unanimous consent of (all of the remaining member(s).

- 7. Management of the Company. The management of the limited liability company is reserved to the Member(s).
- 8. Initial Members. The Initial members of the limited liability company are ROBERT A. KAMM and CYNTHIA L. KAMM, his wife. Their membership interest shall be held as tenants by the entirety with rights of survivorship.
