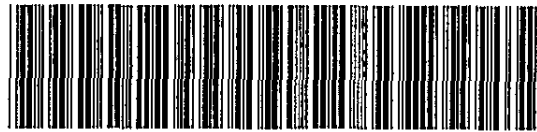




**FIRST:** The Articles of Organization were filed on June 22, 2004 and assigned document number L04000047045.
