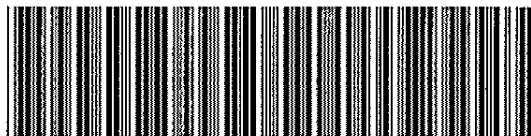

**ARTICLES OF ORGANIZATION OF  
VENITA, LLC  
A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned, being the single member, is authorized to execute and file these Articles, and hereby certifies that:

**ARTICLE I - Name:**

The name of the limited liability company is VENITA, LLC.

**ARTICLE II - Address**

expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company unless three-fourths of the members vote to terminate the business.

#### **ARTICLE VIII - Members' Rights**

Pursuant to section 608.4235 of the Florida statutes, no member of the limited liability company other than the manager shall be an agent of the company solely by virtue of being a member, and no member other than the manager shall have authority to incur debt or contractual liability on behalf of the company solely by virtue of being a member. Any Operating Agreement of the company as defined in Florida statutes section 608.402(24) must be in writing and signed by all the initial members.
