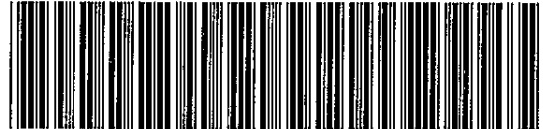

ARTICLES OF ORGANIZATION

(Initial Manager)

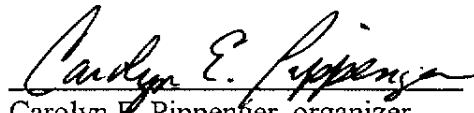

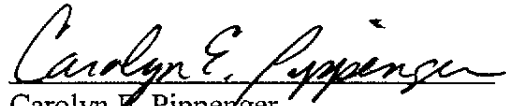
