ARTICLES OF ORGANIZATION OF CHARLOTTE PROPERTIES MANAGER, LLC

ON THE SECONDANCES ON SECONDANCES

The undersigned organizers, who are members of CHARLOTTE PROPERTIES MANAGER, LLC ("Company") under the Florida Limited Liability Company Act, hereby adopt the following Articles of Organization.

ARTICLE I - NAME

The name of the Company is CHARLOTTE PROPERTIES MANAGER, LLC.

ARTICLE II - PRINCIPAL OFFICE

The mailing address and street address of the Company is 9550 Regency Square Boulevard, Suite 902, Jacksonville, Florida 32225.

ARTICLE III - INITIAL REGISTERED AGENT AND ADDRESS

The name and street address of the initial registered agent are Christopher C. Simms, 9550 Regency Square Boulevard, Suite 902, Jacksonville, Florida 32225.

ARTICLE IV - MANAGERS

The management of the Company shall be vested in two Managing Members of the Company as provided in its Operating Agreement. The name and addresses of the initial Managing Members are Gregory S. Simms and Christopher C. Simms, 9550 Regency Square Boulevard, Suite 902, Jacksonville, Florida 32225.

ARTICLE V - ADDITIONAL PROVISIONS

- 1. The purpose of the Company is limited solely to (i) serving as managing member of GMC Charlotte, LLC, a Florida limited liability company, in connection with its owning, holding, selling, leasing, transferring, exchanging, operating and managing the properties known as Emerald Bay, 5029 Cherrycrest Lane, Charlotte North Carolina, The Highlands, 639 Archdale Drive, Charlotte, North Carolina and Chateau Village, 2442 Chartres Drive, Gastonia, North Carolina (the "Property"), (ii) entering into a Loan with GMAC Commercial Mortgage ("Lender") (the "Loan"), and (iii) transacting any and all lawful business that is incident, necessary and appropriate to accomplish the foregoing.
- 2. Notwithstanding any other provision of the Operating Agreement to the contrary, so long as the Loan is outstanding, the Company may not, without the prior written consent of Lender, do any of the following:
- (a) engage in any business or activity other than those set forth in Paragraph 1 above; or

- ON TON SUN 23 AN 8:30 incur any indebtedness or assume or guarantee any indebtedness other than the Loan and unsecured trade debt incurred in the ordinary course of business which is payable within thirty (30) days of when incurred.
- So long as the First Mortgage is outstanding, the Company may not do any of the following:
 - (a) dissolve or liquidate, in whole or in part;
- consolidate or merge with or into any other entity or convey or transfer its (b) properties and assets substantially as an entirety to any person or entity;
- amend or cause to be amended these Articles or the Operating Agreement with (c) respect to changing the sole purpose of the Company or the separateness covenants contained in Paragraph 4 below; or
 - take any action that might cause the Company to become insolvent. (d)
 - 4. The Company shall:
 - maintain books and records separate from any other person or entity; (a)
 - maintain its bank accounts separate from any other person or entity; (b)
- not commingle its assets with those of any other person or entity and hold all (c) of its assets in its own name;
 - **(b)** conduct its own business in its own name;
- (e) maintain separate financial statements, showing its assets and liabilities separate and apart from those of any other person or entity;
 - pay its own liabilities and expenses only out of its own funds; **(f)**
 - observe all limited liability company and other organizational formalities; (g)
- (b) maintain an arm's length relationship with its affiliates and enter into transactions with affiliates only on a commercially reasonable basis;
 - pay the salaries of its own employees from its own funds; (i)
- maintain a sufficient number of employees in light of its contemplated (i) business operations;
 - not guarantee or become obligated for the debts of any other entity or person; (k)

- TAIL AND STATE OF THE STATE OF not hold out its credit as being available to satisfy the obligations of any o **(1)** person or entity:
- not acquire the obligations or securities of its affiliates or owners, including (m) partners, members or shareholders, as appropriate;
- not make loans to any other person or entity or buy or hold evidence of indebtedness issued by any other person or entity (other than cash and investment-grade securities);
- (0) allocate fairly and reasonably any overhead expenses that are shared with an affiliate, including paying for office space and services performed by any employee of an affiliate;
 - (p) use separate stationery, invoices, and checks bearing its own name;
 - not pledge its assets for the benefit of any other person or entity; **(q)**
 - hold itself out as a separate identity; (r)
 - (s) correct any known misunderstanding regarding its separate identity;
 - (t) not identify itself as a division of any other person or entity; and
 - maintain adequate capital in light of its contemplated business operations.
- So long as the Loan is outstanding, the unanimous consent of all of the Members is required for the Company to:
 - (a) institute proceedings to be adjudicated bankrupt or insolvent;
 - **(b)** consent to the institution of bankruptcy or insolvency proceedings against it;
- file a petition seeking, or consent to, reorganization or relief under any applicable federal or state law relating to bankruptcy;
- (d) seek or consent to the appointment of a receiver, liquidator, conservator, assignee, trustee, sequestrator, custodian or any other similar official of the Company or a substantial part of its properties;
 - (e) make any assignment for the benefit of creditors;
 - **(f)** admit in writing its inability to pay its debts generally as they become due;
- otherwise seek relief under any laws relating to the relief from debts or the (g) protection of debtors generally;
 - (h) take any action in furtherance of any of the preceding actions;
 - (i) engage in transactions with affiliates; or

5. So long as the Loan is outstanding, no Member of the Company may transfer any direct or indirect ownership interest in the Company such that the transferce owns more than a 49% interest in the Company (or such other interest as specified in the Loan Agreement) unless such transfer is conditioned upon the delivery of an acceptable Non-Consolidation Opinion (as defined below) to the Londer and to any nationally recognized rating agency which has been requested by the Lender or any transferce of the Lender to rate any issue of securities issued in respect of a pool of mortgage loans which includes the Loan (the "Certificates") and which is then rating, or expected to rate, such Certificates (individually, a "Rating Agency"), concerning as applicable, the Company, the new manuferest and/or their respective owners.

For purposes of this Paragraph 5, "Non-Consolidation Opinion" shall mean an opinion of counsel to the Company (reasonably satisfactory to the Lender and each Rating Agency in form and substance, from counsel reasonably satisfactory to the Lender and each Rating Agency and containing assumptions, limitations and qualifications customary for opinions of such type) to the affect that a court of competent jurisdiction in a proceeding under the United States Bankruptcy Code would not consolidate the assets and liabilities of the Company with those of any United States Bankruptcy Code, and, if applicable, to the Company, that any such transfer would not be a fraudulent conveyance under the United States Bankruptcy Code.
