**Amended and Restated
Articles of Organization
of
Onicx LLC**

The undersigned, in their capacities as members of Onicx LLC, a Florida limited liability company (the "*Company*"), have executed these Amended and Restated Articles of Organization ("*these Restated Articles*"), as adopted by the Company on July 1, 2006, pursuant to a written agreement by such members, constituting all of the members of the Company. Such action by the members was sufficient for such approval.

These Restated Articles amend, restate and supersede in the entirety the Company's Articles of Organization electronically filed with the Florida Secretary of State on June 24, 2004 (the "*Initial Articles*").

These Restated Articles are adopted in order to (i) confirm that BJTGC Inc. is no longer a member of the Company and that Nollid Inc. is currently the sole member, (ii) otherwise update the information previously provided; and (iii) provide in a single document, for convenient reference, the Company's complete current articles of organization, that includes the aforesaid changes in the Initial Articles.

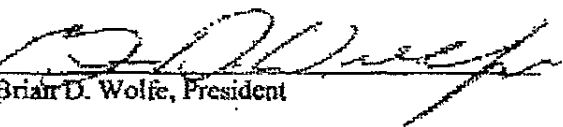
The effective date for the organization of the Company was June 24, 2004, and the Company shall have perpetual existence.
