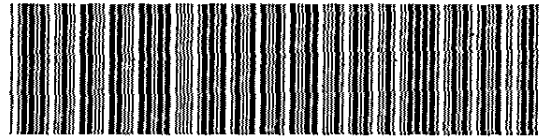

ARTICLES OF ORGANIZATION

Article I - Name



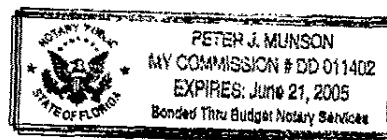
