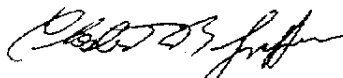

ARTICLE II-ADDRESS

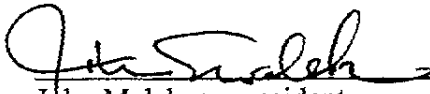
