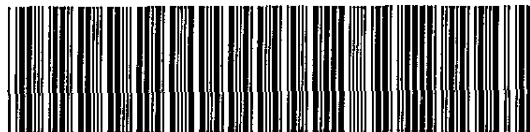


- FIRST:** The date of filing of the articles of organization was June 22, 2004.
