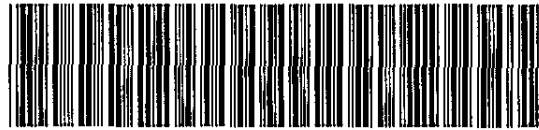

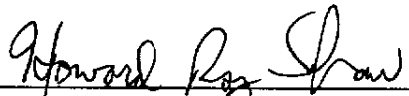
1. NAME. The name of the limited liability company is SHAW'S LAND CLEARING, LLC.
