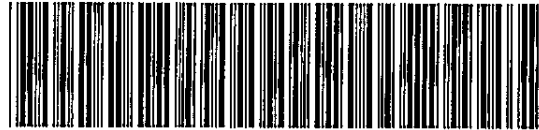

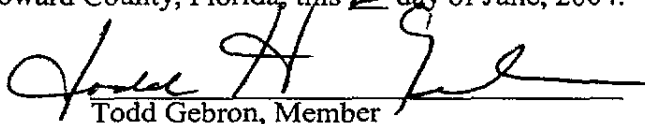
**ARTICLE I**

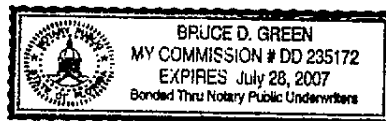

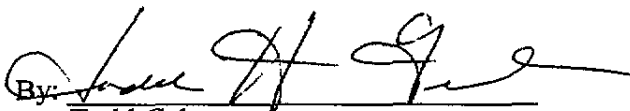
