ARTICLE I

NAME AND ADDRESS

The name of this Limited Liability Company shall be Bida, LLC (the "Company"). The mailing address and street address of the principal office of the Company is 655 Fountainhead Way, Naples, Florida 34103.

LIMITATIONS ON MEMBERS

Pursuant to Section 608.424 of the Florida Limited Liability Company Act, no Member of the Company shall be an agent of the Company solely by virtue of being a member, and no Member shall have authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a member.

ARTICLE VII

RIGHT TO CONTINUE BUSINESS OF COMPANY

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of any Member of the Company, or upon the occurrence of any other event that terminates the continued membership of a Member in the Company, the remaining Member or Members shall have the right to continue the business of the Company in accordance with the terms and conditions of the Company's Operating Agreement.
