The property, business and affairs of the limited liability company shall be managed by the members.

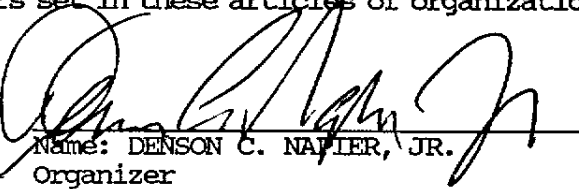
