ARTICLES OF ORGANIZATION
OF
REGEN POLYMER PRODUCTS, LLC

The undersigned authorized representative executes these Articles of Organization to form a limited liability company under the Florida Limited Liability Company Act:

ARTICLE I. NAME

The name of the limited liability company is REGEN POLYMER PRODUCTS, LLC.

ARTICLE II. ADDRESS

The mailing and street address of the principal office of the limited liability company is 2204 S. Exmoor Street, Tampa, Florida 33629.

ARTICLE III. REGISTERED AGENT AND OFFICE

ARTICLE IV. MANAGEMENT


