

ARTICLES OF ORGANIZATION FOR INVESTMENT CAPITAL HOLDINGS, L.L.C.

A LIMITED LIABILITY COMPANY

KNOW ALL MEN BY THESE PRESENTS: That the undersigned, desiring to form a limited liability company under the laws of the State of Florida, do hereby sign, verify and deliver to the Secretary of State of the State of Florida these Articles of Organization.

ARTICLE I - Name

The name of the Limited Liability Company is: Investment Capital Holdings, L.L.C., a limited liability company (the "Company").

ARTICLE II - Address

In the event the remaining members fail to continue the business of the Company within such ninety (90) day period, the Company shall be dissolved and liquidated.
