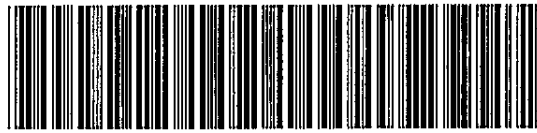

**ARTICLES OF ORGANIZATION
FOR INVESTMENT CAPITAL HOLDINGS, L.L.C.**

A LIMITED LIABILITY COMPANY

KNOW ALL MEN BY THESE PRESENTS: That the undersigned, desiring to form a limited liability company under the laws of the State of Florida, do hereby sign, verify and deliver to the Secretary of State of the State of Florida these Articles of Organization.

ARTICLE I – Name

The name of the Limited Liability Company is: Investment Capital Holdings, L.L.C., a limited liability company (the "Company").

ARTICLE II – Address

The mailing address and street address of the principal office of the Limited Liability Company is:

Article III – Duration

The company shall exist for a period of thirty (30) years from and after the date the Florida Secretary of State issues a Certificate of Formation, unless dissolved according to law.

Article IV – Management

The Limited Liability Company is to be managed by one manager or more than one manager and is therefore a manager-managed Limited Liability Company.

Article V – Admission of Additional Members

The existing members shall have the right to admit additional members to the Company upon such terms and conditions as the existing and additional members shall agree at their sole discretion. Any member who is subsequently admitted as member of the Company shall have all the rights and obligations of a member under the "Limited Liability Company Agreement."

Article VI – Members right to Continue Business

In the event of death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership

of a member in the Company, the remaining members of the Company shall have membership based on their relative contributions as set forth in the "Limited Liability Company Agreement" and agree to continue the business of the Company. The remaining members must agree within ninety (90) days from the date of such event whether to continue the business of the Company. In the event the remaining members fail to continue the business of the Company within such ninety (90) day period, the Company shall be dissolved and liquidated.
