The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company shall be MCO THOROUGHBREDS, LLCC

ARTICLE II – ADDRESS

The mailing address of the principal office of the company shall be 5415 W SLIGH AVE, SUITE 107, TAMPA FL 33634

ARTICLE III – DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is earlier dissolved as provided in these articles.

ARTICLE IV - REGISTERED OFFICE AGENT

The name and street address of the registered agent of the company in the State of Florida is Donald Manuchia, 5415 W Sligh Ave, Suite 107, Tampa, FL 33634

ARTICLE V - CAPITAL CONTRIBUTIONS

The members of the company shall contribute to the capital of the company cash or property as unanimously agreed to by all members.

The company shall be managed by a manager in accordance with the regulations adopted by the members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.
