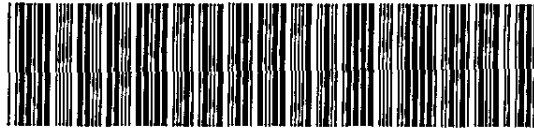



The Managing Members of the Company shall have the right to admit additional members or substitute any existing member for a new member as may be more fully provided in an Operating Agreement of the Company to be adopted by the existing members at a later date, if any.


ARTICLE VII - Limitations of Liability
