ARTICLES OF ORGANIZATION

OF

ACCORD FARMS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, adopts and files the following Articles of Organization ("the Articles").

ARTICLE I

NAME

The name of the limited liability company ("the company") is:

ADDRESS
