The undersigned (the "Member") being the sole Member of ZMG DEERFIELD, LLC, f/k/a ZMG COLETTA DEERFIELD, LLC, ("Company") hereby executes and adopts the following Amended and Restated Articles of Organization pursuant to Chapter 608, Section 608.411, Fla. Stat. under the Florida Limited Liability Company Act, which Amended and Restated Articles of Organization replace in their entirety the previously adopted Articles of Organization of Company filed with the Florida Secretary of State on June 29, 2004:

**ARTICLE I
NAME**

The name of the limited liability company is ZMG DEERFIELD, LLC.

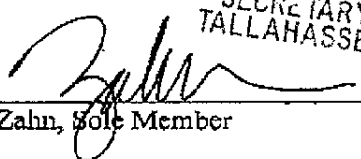

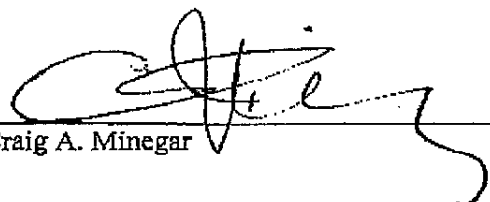
