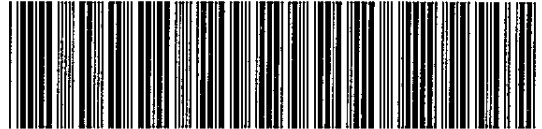

ARTICLES OF ORGANIZATION OF
AMDUR ART CONSULTANTS, LLC

The undersigned Member hereby makes, subscribes, and files these Articles of Organization for the purpose of forming a limited liability company under the Florida Limited Liability Company Act:

1. **Name.** The name of the limited liability company is Amdur Art Consultants, LLC
2. **Duration.** The period of duration of the limited liability company is perpetual.
3. **Principal Office.** The mailing address and the street address of the principal office of the limited liability company is, 327 - 71st Street, Miami Beach, Florida 33141.
4. **Registered Agent and Office.** The name and address of its initial registered agent in the State of Florida, whose Consent to Appointment as Registered Agent accompanies these Articles of Organization, is Laurence A. Herrup, 327 - 71st Street, Miami Beach, Florida 33141.

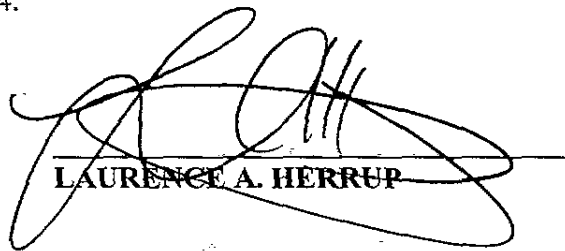
