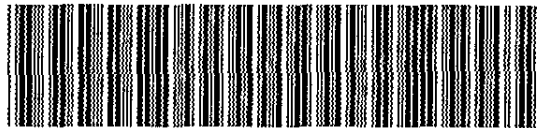

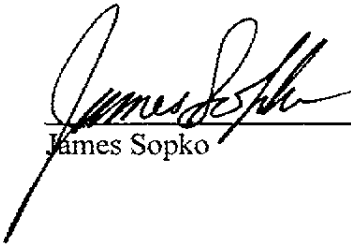
ARTICLE VI
