The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be PIRKA, LLC, a limited liability company (the "Company").

ARTICLE II - ADDRESS

ARTICLE V -- CAPITAL CONTRIBUTIONS

2004 JUN 29 A 9: 06 The members of the company shall contribute to the capital of the Company the STATE cash or property set forth in and described in the Limited Liability Company Operating FLORIDA Agreement on file at the principal office of the Company (the "Operating Agreement").

<u>ARTICLE VI - ADDITIONAL CAPITAL CONTRIBUTIONS</u>

The Company shall be managed by a manager or managers in accordance with the Articles of Organization, the Operating Agreement, the Regulations adopted by the members for the management of the business and the ordinary and customary affairs of the Company. The Regulations and the Operating Agreement, if any, shall determine the manner in which such the Manager(s) are elected and appointed, and may contain any provisions for the regulation and management of the affairs of the company not inconsistent with the law or these Articles of Organization.
