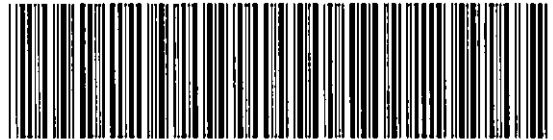

*The undersigned, being the sole member of Third Street Investments, LLC, adopts the following Amended and Restated Articles of Organization pursuant to the authority and provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act:*

**FIRST:** The name of the limited liability company filing these Amended and Restated Articles of Organization is Third Street Investments, LLC (the "**Company**").

The Articles of Organization of the Company were filed with the Division of Corporations of the Florida Department of State on July 1, 2004 under Document No. 1.04000049576.

**SECOND:** These Amended and Restated Articles of Organization were approved by the sole Member.

**MANAGEMENT**


The Company shall be member-managed in accordance with the Amended and Restated Operating Agreement (the "**Operating Agreement**") of the Company.
