**ARTICLES OF ORGANIZATION  
OF  
GLENCOE TRAILS, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I - NAME**

The name of the limited liability company shall be GLENCOE TRAILS, LLC ("company").

**ARTICLE II - ADDRESS**

The mailing address and street address of the principal office of the company is 620 E. 3<sup>rd</sup> Avenue, New Smyrna Beach, FL 32169.

**ARTICLE III - DURATION**

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State or on another effective date as specified. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these articles of organization or in the regulations.

**AGENT ARTICLE IV - REGISTERED OFFICE AND AGENT**

The name and street address of the registered agent of the company in the state of Florida are JAMES S. COOMBER, 620 E. 3<sup>rd</sup> Avenue, New Smyrna Beach, FL 32169.

**ARTICLE V - MANAGEMENT**

The company shall be managed by its members in accordance with regulations adopted by the members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.


**CERTIFICATE OF DESIGNATION OF REGISTERED


