The Members with the consent of the Manger shall have the right to admit new members from time to time.

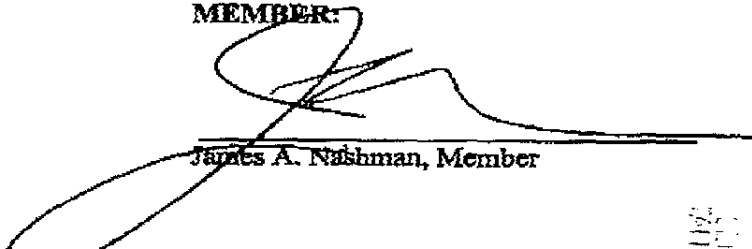
ARTICLE VII
