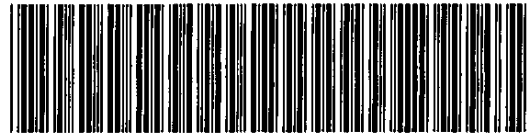

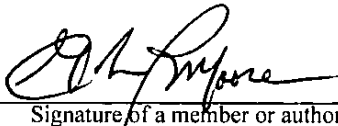
**FIRST:** The Articles of Organization were filed on July 2, 2004 and assigned document number L04000050013.
