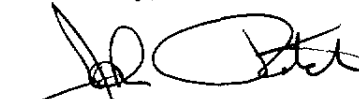

**ARTICLES OF ORGANIZATION
OF

ARTICLE I

NAME.

The name of this Company is URBAN WORM, LLC.

ARTICLE II

PURPOSE.

This Company is organized for the purpose of transacting any and all lawful business for which limited liability companies may be formed under Chapter 608 of the Florida Statutes.

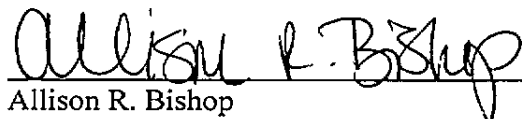

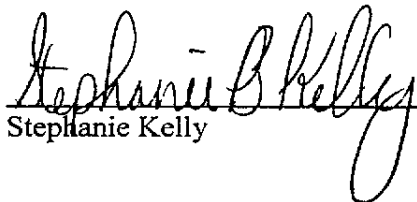
AMENDMENT.

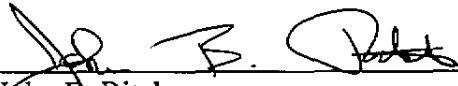
