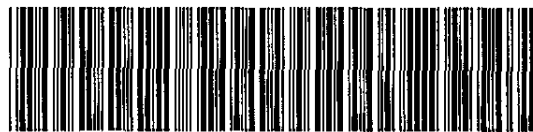

ARTICLE 1
NAME

The name of this limited liability company is First Dream Homes, LLC.

ARTICLE 2
PERIOD OF DURATION
