**ARTICLES OF ORGANIZATION

**ARTICLE I
NAME AND ADDRESS**

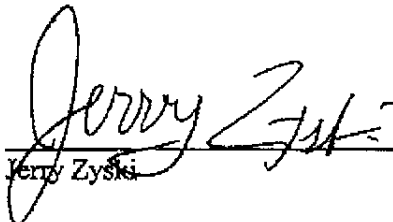
