Articles of Organization of

**ARTICLE I:**  
**Name**

The name of the limited liability company ("Company") is **EDUCATION TIME ASSC, LLC**, a Florida Limited Liability Company.

**ARTICLE II:**  
**Duration**

The period of duration for the Company is perpetual, beginning on the date these Articles of Organization are filed by the Florida Department of State.


