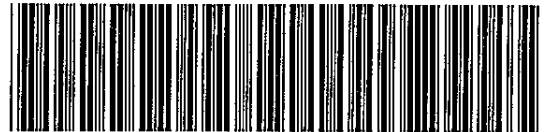




ARTICLE VI - INDEMNIFICATION


