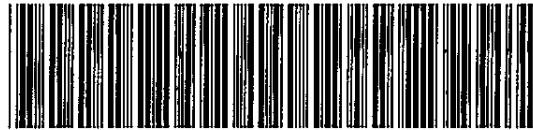

The period of duration for this limited liability company shall be perpetual from July 1, 2004, which shall be the effective date.

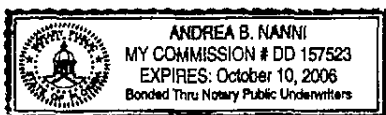
