## ARTICLES OF ORGANIZATION OF

# ALSTOTT ROREBECK MARINI DEVELOPMENT AND HOLDINGS LLC (a Florida Limited Liability Company)

The undersigned, a representative of the members of Alstott Rorebeck Marini Development and Holdings LLC, a Florida limited liability company (the "Company") under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby submit the following Articles of Organization:

#### ARTICLE I

#### Name

The name of this Limited Liability Company is Alstott Rorebeck Marini Development and Holdings LLC (the "Company").

#### ARTICLE II

#### Address
