### Articles of Organization for LUCKY VENTURES TWENTY-ONE LLC

The undersigned person, as the organizer of the formation of a limited liability company (the "Company") under the laws of the State of Florida, does hereby certify that the foregoing  $\bigcirc$  3 03 constitutes the proposed Articles of Incorporation for the Company:

- 1. Name. The name of the Company shall be: LUCKY VENTURES TWENTY-ONE LLC.
- **2. Duration.** The LLC's period of duration is perpetual, unless sooner dissolved by the members or as provided by statute.

- Admission of Additional Members. New members may be admitted only upon 3: 03 such terms as set forth by the member-manager pursuant to provisions in the operating Agreement. Contributions required of a new member shall be STATE determined in accordance with the Operating Agreement. A member's interest in the Company may not be sold or otherwise transferred except with the prior written approval of the member-manager, otherwise in accordance with the Operating Agreement. Additional restrictions and conditions on membership may be set forth in the Operating Agreement.
- **8. Continuity.** The members of this limited liability company have the right to continue the business upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or occurrence of any other event which terminates the continued membership of a member in this limited liability company. Continuation may occur only pursuant to the terms of the F.S. 608.
- **9. Withdrawal of a Member.** The withdrawal of a member from the company may occur only pursuant to the terms of F.S. 608.
