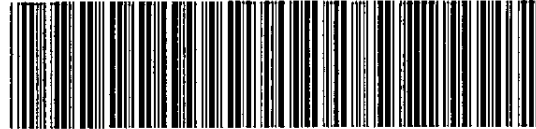

2.- SOS discovered attachments of ceiling trusses for Garages in Florida are different than examples shown in Las Vegas (location of parent Company)

the increases in cost were 3 times the per unit installed due to: a) high ceilings and trusses lay out not capable to support the weight necessary to support SOS

steel systems for overhead Storage. Advertising returns by sales people were grossly overstated. No balance between revenue vs. cost.


