ARTICLE I

Name. The name of the limited liability company ("Company") is MIGUN CENTRAL, L.L.C.

Every proposed amendment to these Articles of Organization shall require the approval of the members, whereupon it shall be proposed to all the members, and, for adoption, shall require the approval at a member's meeting of a majority of the members entitled to vote thereon; alternatively, all of the members may sign a written statement adopting the proposed Amendment to these Articles of Organization.

ARTICLE VII

Operating Agreement. The Operating Agreement of the Company shall be made, altered or rescinded by a majority vote of the members of the Company at a meeting of the members.

ARTICLE VIII
