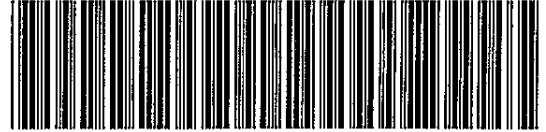


1. **Name.** The name of this company shall be 7 Stars L.L.C..




