**ARTICLES OF ORGANIZATION
OF
HOGTOWN RESTAURANT, LLC**

The undersigned members adopt the following Articles of Organization pursuant to the provisions of the Florida Limited Liability Company Act (the "Act").

**ARTICLE I
NAME OF COMPANY**

The name of the limited liability company is HOGTOWN RESTAURANT, LLC (the "Company").

**ARTICLE II
PERIOD OF DURATION**

The Company shall terminate on July 6, 2104.

**ARTICLE III
REGISTERED OFFICE AND AGENT**

The address of the Company's principal office and mailing address is 2236 N.W. 38th Avenue, Gainesville FL 32605, and the name and address of the Company's initial registered agent in the State of Florida is Katrina Brown, 2236 N.W. 38th Avenue, Gainesville FL 32605.

**ARTICLE IV
REQUIREMENTS FOR ADMISSION OF ADDITIONAL MEMBERS**

Additional persons may be admitted to the Company as members and membership interests may be created and issued to these persons upon the approval of the members entitled to vote.

**ARTICLE V
DISSOLUTION AND RIGHT TO CONTINUE BUSINESS**

The Company shall be dissolved upon the first to occur of the following:

- (a) The expiration of the term of the Company;
- (b) The unanimous written consent of all the Company's members;
- (c) The death, retirement, resignation, expulsion, dissolution or bankruptcy of a member, or any other event which terminates the membership of a member in the Company, unless within ninety (90) days after such event all of the remaining members agree in writing to continue the business of the Company.

**ARTICLE VI

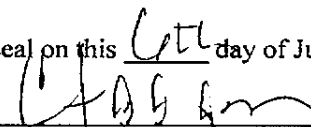
