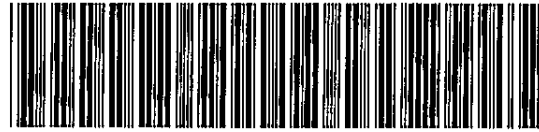

The power to adopt, alter, amend, or repeal the Regulations of the Company is vested entirely in the managers listed in Article V.


