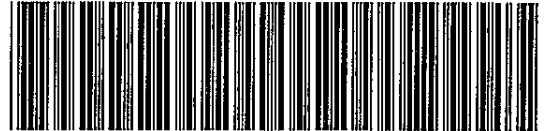

ARTICLES OF ORGANIZATION

The undersigned, pursuant to the provisions of Chapter 608, Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida, sets forth the following:

ARTICLE I - Name

The name of the Limited Liability Company is Global Tower Services, LLC.

ARTICLE II - Address

The mailing address and street address of the principal office of the Limited Liability Company is 340 W 23rd Street, Panama City, Florida, 32405.

ARTICLE III - Duration

The period of duration for the Limited Liability Company shall commence five days prior to the filing of these Articles in the office of the Secretary of State of Florida and shall terminate upon dissolution pursuant to the provisions of the Florida Limited Liability Company Act.

The Limited Liability Company shall have one class and one series of members.

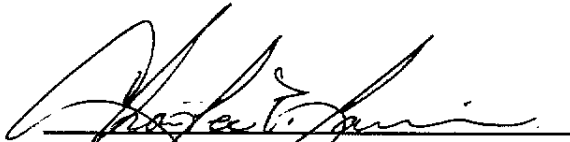

ARTICLE X - REGULATIONS

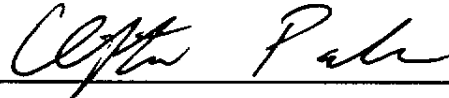
The power to adopt, alter, amend or repeal the Regulations shall be vested in the Members.

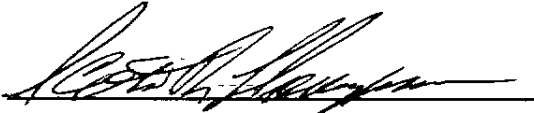
